A. Call to Order: The meeting was called to order at 7:04PM.

B. Attendance: Director Amanda Reynolds Cooper, Chair, Bob Lamothe, Treasurer, Diane Crow, Trustee, Chris Hendry and Vice Chair, Liz Kerouac and Secretary Deb Knowlton arriving at 7:30PM.

C. Officer's Reports

- a) Secretary: A motion was made by Chris and seconded by Diane to approve the minutes of the August meeting. Motion passed, AIF.
- b) Chairperson: Shared Friends report from outgoing Friends President Christine Bushway:
 - -New Friends President is Mary Lou Heran. Christine will be sharing Vice President duties with Patt Walker.
 - -The board voted to purchase the McAuliffe-Shepard Discovery library pass for a year.
 - -School book set bookbags funding request from Stacy Mazur was approved as well.
- c) Treasurer: Diane shared the September Treasurer's Report.

D. Reports

- a) The Director's Report: Amanda's report and financials were received and reviewed.

- b) **Building:** Two requests for modified hours for Teen events prompted Diane to make a motion that was seconded by Deb to stay open until 10 PM on October 5 for a NH Astronomical Society sky watch event and until 8 PM on October 13th for an After-Hours Lan Party. Motion passed, AIF.

- c) **Policy:** The Board engaged in a brainstorming session regarding the snow cancellation policy. The Appendix B Emergency Closures Policy, last updated on 3/13, was left intact. The Section 22 Emergency Closure Document was updated in places but a decision will be made at October meeting about the final wording.
- **G. Monthly Donations:** A motion was made by Liz and seconded by Chris to accept \$80 in monthly donations, and the \$20 Hannaford gift card, and other products. Motion passed, AIF.
- **H. Summary of Decisions:** Motions were made to accept the minutes; to approve the modification of library hours for two events and to accept the donations and gifts for teens.
