# TOWN CLERK'S REPORT

### **TOWN WARRANT FOR 1936**

# TOWN OF HAMPTON STATE OF NEW HAMPSHIRE

(L. S.)

To the inhabitants of the town of Hampton, in the County of Rockingham, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Hampton on Tuesday the Tenth day of March next, at Ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose by Australian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of Taxes and three Auditors.

Article 2. To choose all necssary officers for the ensuing year.

Article 3. To raise and appropriate such sums of money as may be necessary for Town Officers' salaries and expenses, election and registration, municipal court, care and supplies for town hall, police department, fire department, moth department, health department, highways and bridges, street lighting, library, town poor, Memorial Day, parks and playgrounds, cemetery, sewer department, sidewalks, comfort station, breakwater, town notes, Hampton Beach and all other necessary charges arising within the Town.

Article 4. To see if the town will give the Selectmen power to borrow money in anticipation of Taxes.

Article 5. To see if the Town will vote to authorize the Justice of the Municipal Court to appoint a Clerk for the same and also provide reasonable compensation for both the Justice and the Clerk.

Article 6. To see if the town will authorize the Selectmen to administer or dispose of any real estate acquired by the town through Tax Collector's deeds.

Article 7. To see if the town will vote to authorize the Selectmen to take action according to the terms of leases against certain or all lease owners leasing land from the Town of Hampton who have not paid their ground rent or taxes, or both.

Article 8. To see if the town will vote a discount of 3% on current year's taxes if paid on or before August 1, 1936.

Article 9. To see if the town will give the Selectmen power to buy land for a gravel pit.

Article 10. To see if the town will vote to finish the construction of the main sewer pipe line to White Island and to borrow a sum not exceeding \$30,000, and to issue and sell in connection therewith notes or bonds of the Town of Hampton in the principal sum of \$30,000 in accordance with Chapter 59 of the Public Laws of New Hampshire as amended, payable in equal annual installments of \$5,000 each, the first installment to be payable one year from date of issue, the time and place of payment, rate of interest, and all other matters in connection therewith to be left to the discretion of the Selectmen.

Article 11. To see if the Town will vote to authorize the Selectmen, if they deem it advisable, to make an application to the Federal Emergency Administration of Public Works for a grant to aid in the construction of the main sewer pipe

line, and to execute any and all contracts or agreements necessary, proper or advisable, in connection therewith, and to accept in the behalf of the Town of Hampton any and all offers in connection therewith.

Article 12. To see if the town will vote to raise and appropriate for the issuance and distribution of printed matter calling attention to the resources and natural advantages of the town, in co-operation with other towns in the Seacoast Regional Development Association, the sum of \$500.00.

Article 13. To see if the town will vote to raise and appropriate the sum of three hundred dollars (\$300.) for a Flag pole at Young's Corner to replace the old one blown down, requested by Mrs. Emma Young.

Article 14. To see if the town will vote for an extension of the Whiteway lights beginning at the Town Hall, Delancey's Corner, Young's Corner and Elimwood Farm, requested by Mrs. Emma Young.

Article 15. To see if the town will vote to authorize the Selectmen, in conjunction and co-operation with the Trustees of the Tuck Memorial and Historical Association, to administer the Tuck Memorial Park and Historical Association and the Tuck Athletic Field as one project; the house to be used as a residence for the caretaker as part of his salary, and the balance of the expense to be taken from the appropriations for Parks and Playgrounds and to raise and appropriate, if necessary, such additional sums for the expense of the above project.

Article 16. To see if the town will vote the entrance fee to the sewer from \$50.00 to \$10.00 to enter, and \$10.00 a year until the total sum of \$50.00 has been paid.

Article 17. To transact any other business that may legally come before said meeting.

# **TOWN WARRANT FOR 1937**

# TOWN OF HAMPTON STATE OF NEW HAMPSHIRE

(L. S.)

To the inhabitants of the Town of Hampton, in the County of Rockingham, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Hampton on Tuesday the Ninth day of March next, at Ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose by Australian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of taxes, and three Auditors.

Article 2. To choose all other necessary officers for the ensuing year.

Article 3. To raise such sums of money as may be necessary for Town Officers' salaries and expenses, election and registration, municipal court, care and supplies for Town Hall, police department, fire department, moth department, health department, highways and bridges, street lighting, library, town poor, Memorial day, parks and playgrounds, cemetery, sewer department, sidewalks, comfort station, breakwater, town notes, Hampton Beach, and all other necessary charges arising within the town.

Article 4. To see if the town will give the selectmen power to borrow money in anticipation of taxes.

Article 5. To see if the Town will vote to pay to the trustees of the trust funds the trust fund notes of \$9630.75, the same to be paid from the surplus now on hand.

- Article 6. To see what action the Town will take concerning the following question, Is it expedient to revise the constitution?
- Article 7. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through tax deeds.
- Article 8. To see if the Town will vote to authorize the Selectmen to take action according to the terms of leases against certain or all lease owners leasing land from the Town of Hampton who have not paid their ground rent or taxes, or both.
- Article 9. To see if the Town will vote a discount of 3% on current year's taxes if paid on or before August 1, 1937.
- Article 10. To see if the Town will vote to give the Selectmen power to buy land for a gravel pit.
- Article 11. To see if the Town will appoint a planning board to consist of 5 members, who will serve without compensation and who shall have the duties and powers conferred by Chapter 55, of the Laws of 1935.
- Article 12. To see if the Town will appropriate the sum of \$500.00 for making studies, preparing maps and for general expenses of the planning board, if the Town votes to appoint such board under the preceding article.
- Article 13. To see if the Town will vote to buy a lot of land adjoining the Library on Academy Avenue, and to raise and appropriate the sum of \$500.00 for same.
- Article 14. To see if the town will vote to authorize the selectmen to contract with the Exeter and Hampton Electric Co. for street lighting for three years.
- Article 15. To see if the Town will vote to authorize the selectmen to attempt to secure lower hydrant and domestic water rates, and to raise and appropriate the sum of \$500.00 for this purpose.

Article 16. To see if the Town will vote to accept from the Hampton Associates, Inc., a deed to and maintain as a highway a certain tract of land 40 feet wide and 200 feet deep running from the easterly side of Lafayette Road to the Northwesterly corner of land of the Hampton Industries, Inc., to be known as Kershaw Avenue.

Article 17. To see if the Town will vote to accept from the Hampton Associates, Inc., a deed of and maintain as a highway a certain tract of land 49.5 feet wide and running from High Street to the Beach Road, as the same is now laid out in accordance with a plan recorded in Rockingham Records, Plat I, Page 3, to be known as Towle Avenue.

Article 18. To see if the Town will vote to appoint a committee to prepare for a tercentenary celebration to be held in 1938, to authorize said committee to invite all towns formerly a part of Hampton to participate, and to raise and appropriate the sum of \$500.00 for the preparation of said celebration.

Article 19. .To raise and appropriate the sum of \$2500.00 for the purpose of building and equipping an incinerator plant and providing a site therefor.

Article 20. To see if the Town will vote to

- A. Raise and appropriate the sum of \$1512.50 for one new man to enable the department to go on the two platoon system.
- B. Raise and appropriate \$400.00 for the maintenance of the fire alarm system.
- C. Raise and appropriate \$300.00 for equipment and equipment repairs.
- D. That an oil burner be installed in the boiler at station 2.
- E. Raise and appropriate \$150.00 for painting and furnishings at station 2.

Article 21. To raise and appropriate for the issuance and distribution of printed matter calling attention to the resources and natural advantages of the town, in cooperation with other towns in the Seacoast Regional Development Association, the sum of \$460.00.

Article 22. To transact any other business that may come before said meeting.

Another year has drawn to a close and I submit to you, the residents of Hampton, my annual report of the nursing services in the Town of Hampton for the year ending January 31, 1937.

Last Spring Dr. Hanrahan, our local dentist, conducted
our dental clinic. Each year there is an increase in the
number of pupils receiving dental correction and it is very
gratifying to watch the improvement in the condition of
the teeth from year to year.
Last winter we had a serious epidemia of measles which

Last winter we had a serious epidemic of measles which spread throughout the town very rapidly. In the Spring it died out and when the last card was removed from the door we were all very thankful.

The nursing service for the policy holders of the Metropolitan Life Insurance Company has been very inactive for some time, and in November it was cancelled in this district. I regret this deeply as it was a great advantage to many. However, the service is still available with the John Hancock Company and I hope it may continue.

On May 1, 1936 we celebrated National Child Health Day throughout the schools of Hampton. We had a very interesting program by Mr. Titus, a representative of the American Red Cross, who gave demonstrations and discussions on Safety.

The week after the close of school in June we held our Child Health Conference at the Centre School. The clinic was sponsored by the New Hampshire State Board of Health, Department of Maternity, Infancy and Child Hygiene, and was under the direction of Florence Clark, R. N., with your own nurse as chairman. This clinic has become an annual activity and its occurrence in June is always anticipated with much enthusiasm by many young mothers who are realizing the importance of the frequent

examination of the pre-school child.

On January 11 I had charge of the Parent-Teacher Association Health Night. I presented a program on the History of Nursing and Medicine, accompanied by slides and pictures.

Feeling that I may serve you more capably, and for my own improvement, I took an extension course in Modern School Health Habits which was sponsored by Harvard and Boston Universities. Also, I attended a week's institute for school nurses which was held at Plymouth Normal School last summer.

This year, due to a change in the arrangement, Dr. Bryer, the school physician, does the examinations in the first and second grades as well as all pupils on the athletic teams. The examination of all the other pupils has become my work and as a result my activities have greatly increased this year.

At school I have been teaching a more definite Health Program and I wish to thank Mr. Hazen and all of the teachers for the splendid cooperation they have shown in my new work.

I organized a large class in First Aid which was most efficiently taught by Mr. Arthur Titus of Exeter.

I wish to express my sincere appreciation for the splendid support of the Selectmen, the School Board, Dr. Bryer, the school faculties and to each citizen of Hampton for their sincere cooperation in my undertakings. I also ask for your suggestions and criticisms, that we may work together to build up a more efficient nursing service for our mutual benefit.

#### LIBRARY REPORT

#### TRUSTEES' REPORT

The trustees of the Hampton Public Library have had as their primary purpose to make the library a source of pride to every resident and a benefit to the whole town. In the pursuit of this objective we feel that we have been to a considerable extent successful. Visitors from out of town often comment upon our well-kept grounds, our beautiful library building, and our up-to-date selection of books and periodicals.

Owing to the generous appropriation by the town we have been able to keep the library open three afternoons and evenings during the fall and winter months, and this additional afternoon and evening have been greatly appreciated by the public. We are glad to be able to state that the reference library is more and more used by the pupils and is of great assistance to them in their work.

In the early part of the winter we had the windows and doors weatherstripped. This should result in a considerable saving in fuel and in additional comfort during the cold months. In the summer the weatherstripping should be a protection from the dust of the street, which more or less injures the books.

The library is in the peculiar position of being submerged by its own success. We are beginning to need additional shelf room for the books. The town is increasing in population and the library building, ample in size when constructed, should be enlarged to meet the growing demands upon it. The additional space could easily be secured by an extension in the rear to correspond with the porch in front. Before this is done, however, the

vacant lot on Academy Avenue, adjoining the library lot, should be acquired so that there will be room for a drive-way after the extension is built. We understand that this lot can now be purchased for a reasonable sum. Should the lot on Academy Avenue be sold and a building erected close to the library, it might detract seriously from the beauty of the structure.

Bingham on the work of the National Youth Administration.

Book Week was observed by the display of the poster "Books To Grow On" and several new juvenile books were purchased at this time.

### REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board of Hampton:

I herewith submit to you my annual report as the Superintendent of your Schools. It will consist in general of an overview of the school year completed last June and a summary of the work done to date during the current school year.

The Hampton schools opened on September 9, 1936 with an enrollment of 283 in the Centre School and 83 in the high school. This fall registration continues the increase that has been evident year by year. This total of 366 pupils compares with 341 of last year and 325 for the fall of 1934.

The fall registration for the grades was 187 or a per teacher load of more than 37 pupils. It is reported by the state board of education that the average per teacher load in New Hampshire for this type of school is 26. The housing of grades 4, 5 and 6 in two rooms has given two teachers charge of 45 and 46 pupils, respectively. This is far too crowded for the best work. It is entirely possible to use one of the junior high rooms as a fifth grade room, although it would somewhat minimize the effectiveness of the school library. It seems, neverherless, that this would be preferable to continued crowding in the grades. The trend of all modern education is an emphasis upon the individual pupil, his own needs, difficulties and progress rather than a mass evaluation of the group. Individual instruction to each of 46 pupils in each subject is a difficult task. It seems that the employment of an additional teacher is educationally economical. Certainly a further increase in the enrollment of these three upper grades would make it physically impossible to seat the pupils.

We, of Hampton, believe that the way to keep a good school continually improving is to retain in our schools our best teachers. This is proven by the comparatively long period of service of our present staff. Each teacher in our elementary grades has been working for the welfare of our children for at least eight years. Their assignments follow.

These teachers have, at least during the past six years, devoted special time and effort to the teaching of Reading in their work, believing that more of actual worth can be accomplished by concentrating upon the fundamental rather than spreading the attack over too many phases of school work. It is therefore a source of satisfaction for us to quote from the Principal of the school, Mr. Hazen. The quotation follows:

"If I were asked to point out the thing which Centre School pupils most excel in, it would be in ability to read. In the two school systems in which I have previously worked about a third of the pupils were definitely handicapped by reading deficiencies. There are no non-readers in the Hampton Junior High School. Judged on a basis of reading tests furnished by the Nashua Junior High School, Hampton pupils are the peers in reading ability of any pupils to whom the tests were given. On this test it was interesting to note that in almost every case the pupils with scores at the low end of the group had had early training in Reading at other schools".

That this training has carried over into other fields can

be shown by the results of tests in Geography, History, Science and allied subjects.

We have felt for some time that added emphasis should be given the subject of Spelling in the grades. Spelling seems to have become a lost art among adults as well as children. To help this situation two definite steps have been taken toward increased efficiency. Samples of seventeen different and modern spelling texts were obtained and submitted to the teachers of this Supervisory Union for their comments and criticisms. It was the opinion of a large majority that for interest, teachability, and skillful application of the words studied, the Modern Life Spellers were the best. These have therefore been ordered for all grades in Hampton. Another approach to the same problem is to be made in that all papers written by pupils in any subject must be correct as to spelling before credit for the work will be given.

Hampton children are provided with many of the facilities usually offered only to children in larger places. Hot lunches are served at cost in the school building during the colder months, the district employing a woman, other than a teacher, to do the actual preparing of the food. The Domestic Arts department, under Miss Janvrin, has charge of the arranging of the menu. This is valuable laboratory practise for the girls in charge and a valuable health measure for all.

The fact that the school and community nurse has her office in the building makes her immediately available for any emergency. This year Mrs. Hay has introduced for the entire school a course in Health. She has outlined the work of each grade and by so doing has done away with the heretofore unrelated and uncoordinated activities of each group, acting separately. I believe this course is unique to Hampton as far as the state of New Hampshire is concerned.

Under the leadership of Mr. Hazen a closer supervision of the playground has been established with a beginning at some form of organized play. The pupils appreciate this and are reacting with real enthusiasm. Mr. Hazen plans to extend this to every pupil as soon as it can be done. This means extra work for the teachers, but it is invaluable as training for social adjustment in the present and future of the pupils' lives.

### THE JUNIOR HIGH SCHOOL

After twelve years of valuable service, Arthur C. Sears resigned as Principal of the Junior High School last August. His long term of service had seen the school advance in numbers and prestige until it is ranked with the best in the state. Mr. Edward H. Hazen, former Principal of the Franklin Junior High School of Keene, N. H. was engaged as our principal. He comes to us after successful experience and the best of training in the junior high field. We have every reason to believe that Hampton Junior High will continue along the path of progress under his guidance.

Two departments of instruction have already been materially strengthened in our school. The Manuel Training room has been equipped with a power grinder, power lathe and a jig saw. The boys of the department are taught the proper care of tools as well as their proper use. Projects are now large units and are properly and painstakingly executed. The interest in this work is intense. New equipment has also been purchased for the elementary science work. One particular instance is the installation of Bunsen burners which greatly widen the variety of experiments that can be completed.

An immediate task before us is the purchasing of suitable reading for the school library. Such material as we have, has been carefully reorganized under the direction of Miss Whytock. The Principal compliments the pupils,

particularly the ninth grade, on the amount of good reading they do. Such a trait should be encouraged.

The teachers responsible for these improvements are listed herewith.

### THE JUNIOR HIGH SCHOOL

Mr. Eastman: Social Science, American History, Junior Business Training, American Life.

Mr. Hazen: General Science, Manual Arts.

Miss Janvrin: Domestic Arts.

Miss Sanborn: English, History of Civilization. Miss Whytock: Algebra, Mathematics, Latin.

Mrs. Coombs: Music, Orchestra, Band, Music Appreciation

### THE MUSIC DEPARTMENT

The standard of music instruction in the Hampton schools is well known. An experienced teacher with ever renewed enthusiasm is in charge of the work. She reports continued progress with several outstanding achievements. These are of such importance that a statement in their regard must be made. The following paragraph taken from her report is over conservative.

"I am beginning, for the first time this year, a definite period of instruction in Music Appreciation for all the elementary grades. This has just been started because the material studied is based on the completed work of the grades, for the first term of the year. This work gives every indication that it will be entirely worthwhile. The teachers themselves find it delightful and instructive."

The large enrollment in the Music Appreciation courses, which is wholly voluntary, bespeaks the interest of our children in music. Believing that the large majority of our children will become listeners rather than participants in music presentation, it seems that we are preparing a

worthwhile service to them by training them to enjoy the really good music. Hampton has an unusually large music library which is constantly in use.

A new project has been started this year in that class instruction in brass instruments is being given under the sponsorship of the school board. A class in string instruments will soon be organized. For this work the pupils and the board share expense. It is believed, in this way, we shall again have large and enthusiastic musical organizations.

As to Hampton's participation in musical events of New Hampshire and New England Mrs. Coombs reports:

"We have, as usual, taken our part in the outstanding musical events of both New Hampshire and New England. Eleven pupils went to Springfield, Mass., in March for the All-New England Band, Orchestra and Chorus Concert. Seven took part in the instrumental program, and four in the vocal. Six of the same pupils played in the All-State Orchestra at Hanover, N. H., in May.

The orchestra and band played at the Hanover Festival as an Instrumental Ensemble. The pupils did very well. Our mark from the judges was 88%. As usual, comment was made by the judges upon our unusually good instrumentation."

Hampton Centre School has now been occupied nearly fourteen years. It is still in good condition and such repairs as may be necessary are of a minor nature. New treads are needed on the stairs at the east end of the building. There is also need of some compartment in which to keep the large musical instruments when not in use. This could be done by a closet in the rear of the auditorium or by utilizing one of the supply closets on the second floor. The new tables in the lunch room are both adequate and attractive. With the purchase of our new chairs this room

will be complete. A survey of the lighting in the various rooms of the school shows inadequate illumination at some of the desks. This can easily be remedied by the installing of a higher powered light at the correct point in the rooms. These improvements, together with the usual repairs, will keep the building in its usual satisfactory condition.

### HAMPTON ACADEMY AND HIGH SCHOOL

Hampton Academy, under the leadership of its energetic headmaster, is moving forward under handicaps. Last year a new subject, Sociology, was introduced. It is the recommendation of the headmaster that Biology be made a part of the program next year. With these two subjects a real difficulty will be nearer solution. The girls of the school are offered a variety of courses not shared by the boys who are forced to choose between the commercial and the academic work. Frequently boys are ill suited to the languages, and commercial work, to them, is a blind alley. For this reason a larger choice should be offered. The introduction of these two additional subjects would be a real help.

The course in automobile driving, sponsored by the state department of education and the state motor vehicle department, is being offered to our pupils this year and, although enrollment is entirely voluntary, a large number are completing the entire course.

The school magazine, the "Script", is published by the pupils as an English project. As motivation and a source of inspiration to the students nothing is more valuable. The work of the English department in the state play contest is just cause of pride to us all.

The employing of a sub-master has relieved Mr. Russell of the immediate supervision of the athletic teams. He has utilized this time for individual conferences with the individual pupils and for vocational guidance. This is a service much needed by our pupils.

Our Academy building, fully suitable for furnishing the training considered necessary in the years before, was declared inadequate in 1921. To meet this problem the town took over the ninth grade in its Centre School. This relieved the situation for the time being. We are now faced with the same condition. A building which would house adequately sixty-five pupils, now must serve 83 pupils, which is our present enrollment. Next year the attendance will be over 90 with no possible decrease in sight.

Education, such as is now given to the pupils with whom our children will later be compelled to compete, demands modern equipment, subjects differentiated according to the pupils' attitudes and interests, a wealth of material with which the pupils may experiment, explore and test for themselves. The present building cannot furnish these vital forces.

Since high school instruction is much more costly than elementary, it would be economy to house again all secondary pupils in one building. In this way a saving on salaries and equipment would be effected. From the cost of a new building and the increased upkeep of a modern educational system must also be deducted the \$6000 tuition asked by the academy annually, beginning with the present school budget. At the present time P. W. A. funds are available for school building purposes, the national government usually furnishing 45% of the cost. Since there is little doubt that building costs will increase materially in the near future, it seems that now is the best time to do a thing which must be done sooner or later.

For future reference I am inserting in this report a copy of the calendar for the current school year.
