

# TOWN CLERK'S REPORT

---

## TOWN WARRANT FOR 1948

---

### TOWN OF HAMPTON STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Hampton, in the County of Rockingham, in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Hampton on Tuesday, the 9th day of March, 1948, at Ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose by Australian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of Taxes, and three Auditors.

Article 2. To choose all other necessary officers for the ensuing year.

Article 3. To raise such sums of money as may be necessary for Town Officers' salaries and expenses, election and registration, municipal court, care and supplies for Town Hall, police department, fire department, moth department, highways and bridges, street lighting, library, town poor, Memorial Day, parks and playgrounds, cemetery, sewer department, sidewalks, comfort station, town notes, Hampton Beach, and all other necessary charges arising within the town.

Article 4. To see if the town will give the Selectmen power to borrow money in anticipation of taxes.

Article 5. To see if the town will authorize the Selectmen to administer, sell or otherwise dispose of any real estate acquired by the town through tax deeds.

Article 6. To see if the town will vote to authorize the Selectmen to take action according to the terms of leases against certain or all lease owners leasing lands from the town of Hampton who have not paid their ground rent, or taxes or both.

Article 7. To see if the town will vote to raise and appropriate the sum of \$446.39 for State Aid roads, if the State contributes \$1,785.55.

Article 8. To see if the Town will vote to authorize the Selectmen to repair the trunk lines of the sewer at the Beach and to purchase such new equipment as the Selectmen may deem necessary at a total cost not to exceed \$15,000.00 and to vote to borrow said sum of \$15,000.00 and to issue notes of the Town of Hampton in the principal amount not exceeding \$15,000.00 in accordance with Chapter 72 of the Revised Laws of 1942 as amended, payable exclusively from funds to be raised by taxation, interest payable semi-annually, principal payable in two installments \$7,500.00 each year, the first installment to be due one year from the date of said notes, and all matters in connection with said notes to be left to the discretion of the Selectmen.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$10,000.00 for sewer extensions at Hampton Beach.

Article 10. To receive the report of the Sewer Committee and to see if the Town will vote to accept the same.

Article 11. To see if the Town will vote to authorize the construction of a system of sewers for sewerage disposal at a cost not to exceed Two Hundred Thousand Dollars, including a system of sewers, the rebuilding and enlarging of the Town sewerage disposal plant, the acquisition either by purchase or eminent domain proceedings of land or lands

necessary for the construction of the sewerage system, and the repayment of the sum of Eight Thousand Two Hundred and Fifty Dollars advanced by the Federal Works Agency of the U. S. Government for the engineering study; the sewer system, the rebuilding and enlarging of the sewerage disposal plant, etc., to be in accordance with the recommendations contained in the report of the Sewer Committee and to authorize a sewer committee consisting of the Board of Selectmen, Charles E. Greenman, Alton P. Tobey, Ernest R. Underwood and John W. R. Brooks, all of said Hampton, or a majority of the said committee of seven, in connection therewith to determine the extent of the system of sewers, to solicit bids from competent contracting firms, to accept the most advantageous bid or bids, to supervise the construction, to see that the contracts are carried out, to accept the project for the Town, and to take any other necessary or desirable action in connection with such bids, contracts, construction and all other matters in connection therewith.

Article 12. To see if the Town will vote to authorize and instruct the Selectmen to proceed to acquire either by purchase or eminent domain proceedings such land or lands or easements therein as the sewer committee shall deem necessary for the construction of any or all of said sewer system.

Article 13. To see if the Town will vote to borrow a sum not exceeding Two Hundred Thousand Dollars and to issue and sell in connection with such borrowing notes and/or bonds of the Town of Hampton in the principal amount not exceeding Two Hundred Thousand Dollars, such notes and/or bonds to be issued pursuant to Chapter 72 of the Revised Laws of 1942 as amended and in accordance with Chapter 399 of the Laws of 1947, payable exclusively from funds to be raised from taxation, to bear interest at a rate not exceeding four per cent per annum payable semi-an-



nually, maturing during a twenty-nine year period, principal payable in annual installments of Seven Thousand Dollars each year for the first twenty-eight years and Four Thousand Dollars on the twenty-ninth year, the first installment to be payable one year from date of said notes and/or bonds, to be sold for not less than par, the time and place of payment of principal and interest, the fixing of the rate of interest, the provisions for the sale of the notes and/or bonds and all other matters in connection therewith to be left to the discretion of the Selectmen.

Article 14. To see if the Town will vote to increase the sewer entrance fee from Fifty Dollars to One Hundred Dollars and to authorize and instruct the Selectmen to take any action that may be necessary to carry out this vote.

Article 15. To see if the Town will vote to require every owner, agent, or tenant of land on which there is a building having or requiring sewerage facilities and adjoining any street through which any common sewer shall be laid, to enter said common sewer by making a sufficient drain from said building to the street line and to instruct the Selectmen or the Board of Health to carry this article into effect.

Article 16. To receive the report of the Planning Board and to see if the Town will vote to adopt a zoning ordinance for the Town of Hampton, the same having been prepared by said Board in accordance with a vote of the Town and public hearings having been held thereon by said Board, a copy of said proposed zoning ordinance being attached hereto and marked Exhibit A.

Article 17. On petition of Leavitt Magrath and nine other legal voters of the Town of Hampton:

To see if the Town will elect to approve of the inclusion of its officers and employees in the Employees' Retirement

ment System of the State of New Hampshire, which system is provided for by chapter 27-A of the Revised Laws, as inserted by chapter 183 of the Laws of 1945, and as provided by chapter 201 of the Laws of 1945 and subsequent amendments thereto.

Article 18. On petition of Donald A. Rand and nine other legal voters of the Town of Hampton:

To see if the Town will raise and appropriate the sum of \$200.00 for the purpose of purchasing Christmas lighting fixtures as a part of a Christmas illumination program sponsored by the Hampton Business Men's Association in conjunction with other civic and Church organizations, said decorations to be located along the Lafayette Road in the Hampton Center Business Section.

Article 19. On petition of J. W. Tucker and twenty-four other legal voters of the Town of Hampton:

To see if the Town will vote to raise and appropriate the sum of five hundred dollars (\$500.00) for the purpose of restoring by all necessary methods of modern tree surgery, the famous Hampton elm, located on Winnacunnet Road at Elmwood Corner, and to empower the Selectmen to engage a competent firm of tree experts to complete the work.

Article 20. On petition of J. W. Tucker and twenty-four other legal voters of the Town of Hampton:

To see if the Town will vote to raise and appropriate the sum of one thousand dollars (\$1,000.00) for the purpose of adequately marking with proper signs, the names of all the streets and roads in the more compact part of Hampton Village and for the allocation of numbers to all houses in this compact section by means of the same system of house-numbering now in use in the Beach section of the Town, and to empower the Selectmen to make all necessary arrangements for such marking of streets and numbering of houses.

Article 21. On petition of Kenneth N. Ross and eleven other legal voters of the Town of Hampton:

To see if the Town will vote to raise and appropriate the sum of \$3,000.00 for the installation of a sewer on the street leading northwesterly from Ocean Boulevard across Ross Acres.

Article 22. On petition of Herbert A. Casassa and twenty-eight other legal voters of the Town of Hampton:

To see if the Town will vote to raise and appropriate the sum of five hundred dollars (\$500.00) to be used for the construction of baseball diamond on Town property in back of the Elementary School.

Article 23. To transact any other business that may legally come before said meeting.

EXHIBIT "A"

PRELIMINARY REPORT  
OF THE PLANNING BOARD  
For The  
TOWN OF HAMPTON, NEW HAMPSHIRE

In order to preserve and improve the attractiveness of the Town of Hampton as a resort community and to continue its desirability as a place in which to live and do business, in order to safeguard the

health, welfare, morals, convenience and safety of its citizens and recreational guests and to provide for an orderly growth in the future, the Town of Hampton in pursuance of authority conferred by Chapters 51 and 53 of the Revised Laws of New Hampshire, 1942, or any amendments thereto, hereby adopts the following ordinance:

**ARTICLE I**  
**Administration and Enforcement**

Section 1. Any person before commencing work on the erection or alteration of any building or structure must first obtain a permit duly granted for such purpose by the public official authorized by the Board of Selectmen to issue such permits. No permits shall be issued when the alteration or construction or change in use would be in violation of any of the provisions of this ordinance nor before a plan is filed which conforms to the regulations of this ordinance or to any amendments thereto. In the event of the damage or destruction by fire, storm or Act of God of any building not conforming to the regulations of this ordinance, said building may be rebuilt for its former non-conforming use provided such construction is started within a year of its damage or destruction and if completed within two years; the new structure shall, however, conform to the Area and Height Regulations of Article IV of this ordinance and to the Building Provisions of Article V.

Section 2. Any person violating any of the provisions of this ordinance shall be subject to a fine not exceeding \$20 for each violation. Each day that any violation is allowed to continue constitutes a separate offense. The Board of Selectmen may institute in the name of the Town any appropriate action or proceedings to prevent, restrain, correct or abate violations of this ordinance.

Section 3. The Selectmen shall appoint a Board of Adjustment conforming in membership and duties to the provision of Chapter 51, Sections 56-57, inclusive, of the Revised Laws of New Hampshire, 1942, or any amendments thereto.

In addition to the general powers granted said Board by said Chapter 51 or any amendments thereto, it may:

1. Permit the erection of additional buildings or enlargement or alteration of existing buildings on the same or an adjacent parcel of land for a trade, business, or other use prohibited in such district.

2. Permit variances from the specific terms of this ordinance where it can be shown that the specific terms would result in unnecessary hardship, but such variances shall be in harmony with its general purpose and intent.

3. In cases where the district boundaries divide present lots or

properties so that a part is in one district and a part is in another, the Board may permit such lot or property to be used for the purposes defined in the less restricted district.

Section 4. This ordinance and the boundaries of districts shown on the Zoning Map may be amended at any annual town meeting in accordance with the provisions of the State Zoning enabling Act, Chapter 51 of the Revised Laws, 1942, or any amendments thereto.

## ARTICLE II

### Districts

For the purposes outlined above four Districts are established, namely, Residence A, Residence B, Business, and General. The Town is hereby divided into these districts as shown on the Zoning Map dated February 2, 1948, and filed with the Town Clerk of said Hampton, and as further described in "Appendix A" attached hereto and made a part hereof. All names of Boulevards, Streets and Roads mentioned herein are as they appear on the Zoning Map.

## ARTICLE III

### Use Regulations

Section 1. Residence A. Districts. In Residence A districts no building or land shall be used for any purpose except one or more of the following:

1. Single or two-family residences, including other purposes accessory to their use as residences, by the owner or tenant, such as offices for doctors, engineers, architects, lawyers, or others, where the number of persons employed on the premises, besides the owner, shall not be more than two, and private garages. The letting of rooms to five or less lodgers, tourists, or boarders shall be considered accessory use.
2. Farm buildings necessary to the operation of a farm, including roadside stands for the sale of farm produce.
3. Churches, schools, libraries.

Section 2. Residence B Districts. In Residence B districts no building or land shall be used for any purpose except one or more of the following:

1. Any use permitted in a Residence A district.
2. Lodging houses where lodgings are let to more than five persons.
3. Apartment houses, tourist cabins, and hotels, including retail business conducted only for the convenience of the residents of the building.

Section 3. Business Districts. In Business districts no building

or land shall be used for any purpose except one or more of the following:

1. Any use permitted in a Residence B. District.
2. Shops, restaurants, and warehouses.
3. Garages, parking lots, and filling stations.
4. Offices, banks.
5. Theaters, halls, clubs.

In a Business district all manufacturing, except that clearly incidental to the business lawfully conducted on the premises, is specifically prohibited.

Section 4. General District. In the General district no building or land shall be used for any purpose except one or more of the following:

1. Any use permitted in a Business district.
2. Light manufacturing, machine shops.
3. Coal, coke, wood, and building materials yards.
4. Such other uses which are not obnoxious or offensive by reason of the emission of smoke, dust, gas, noise, or odor; but the following uses are specifically excluded from all districts; junk yards, dumps, storage of abandoned automobiles, trailer, or trailer camps, race tracks, roller-skating rinks, roller coasters, 'the whip', merry-go-rounds, and/or any other similar commercial amusements."

#### ARTICLE IV

##### Area and Height Regulations

Section 1. Residence A Districts. In Residence A districts the maximum height of any structure shall not exceed three stories or 40 feet in height, nor shall any residential structure contain less than 400 square feet per family.

Section 2. Residence B. Districts. In Residence B districts the maximum height of any structure shall not exceed four stories or 50 feet in height.

Section 3. No structure in either Residence A or B districts shall be placed closer than 7 feet to the nearest lot line or to any other building on the same lot, and in no case closer than 10 feet from the street frontage or frontages. Steps or ground level terraces shall not be considered a part of the structure for the purpose of this section, but all porches, piazzas and other similar elements shall be considered a part of the structure.

#### ARTICLE V

##### Construction Provisions

Section 1. Construction. No building shall be erected or altered

for any purpose which does not conform to safe standards as herein after defined.

Section 2. Roof Coverings. No roof of any building in the Residence A, B, and Business districts shall be covered or re-covered in whole or in part except with non-combustible or fire-resisting roofing materials.

Section 3. Firestops. No building of wood or other combustible material shall be erected, altered, remodeled or enlarged without providing firestops in every combustible wall or partition, at every floor and between floor joists at every partition, of the new construction.

Section 4. Chimney Construction. No chimney shall be built, erected, or altered below the roof unless containing a tile or brick lining and with an iron clean-out door at or near its base, and where enclosed by woodwork or other combustible material shall be no closer than one inch to the chimney, and no chimney shall have its base resting upon any floor or beam of combustible material.

Section 5. Smoke Pipes. No smoke pipes shall be installed or erected, so as to be within twelve inches of any combustible floor or ceiling, unless amply protected with non-combustible material. No smoke pipe shall be installed or erected which passes into or through partitions or walls of combustible material, except when guarded by a double collar of metal with air space of at least five inches, or at least five inches of brick or other non-combustible material between the pipe and the combustible material.

## ARTICLE VI Permits and Inspection

Section 1. No person shall undertake any construction or alteration in connection with any of the provisions of Article V until a written permit for such construction or alteration has been secured from the Building Inspector. A permit shall not be required in the case of repairs unless such repairs include alteration or new construction.

The Building Inspector before issuing the permit may require a plan of the proposed work. He shall inspect all buildings or structures during construction or alteration to see that the provisions of this ordinance are complied with, and whenever in his opinion, the provisions of this ordinance are not complied with, he shall order such work in violation to be stopped until the violation has been remedied and shall forthwith report such violations to the Selectmen for appropriate action.

Section 2. The Building Inspector at the time of the issuing of a

permit by him shall collect from the applicant a fee based on the following scale:

\$2 per \$1,000 based on a fair estimate of the total cost of construction or alteration but in no case shall the fee be less than \$2. In any case where in the opinion of the Building Inspector the total cost of the alteration or new construction shall amount to less than \$100 the Building Inspector may waive the inspection and the fee.

The Building Inspector for his services shall be entitled to one-half of the fee collected and the remaining one-half shall be paid by him to the Town each month.

Section 3. A Building Inspector shall be appointed annually by the Selectmen, and in the event of the disability, absence, or disqualification of the Building Inspector, the Selectmen shall appoint an Inspector to act in his stead.

#### **ARTICLE VII**

##### **Validity**

If any section or part of section or paragraph of this Ordinance is declared invalid or unconstitutional, it shall not be held to invalidate or impair the validity, force or effect of any other section or sections or part of a section or paragraph of this Ordinance.

#### **ARTICLE VIII**

##### **Effective**

Section 1. This ordinance shall take effect upon its passage.

#### **APPENDIX A**

#### **RESIDENCE "A"                      EXETER ROAD                      HAMPTON VILLAGE**

Beginning at a point in the centerline of location of the Boston and Maine Railroad distant 200 feet southerly from the southerly sideline of Exeter Road; thence running in a general northwesterly direction by a line parallel to and 200 feet southwesterly from the southwesterly sideline of said Road to a point in the easterly sideline of the Hadley Garage Property projected southerly; thence turning and running northerly by said easterly sideline and its projection southerly to a point 200 feet northerly from the northerly sideline of said Exeter Road; thence turning and running in a southeasterly direction by a line parallel to and 200 feet northeasterly from the northeasterly sideline of said Road to the centerline of location of said railroad; thence turning and running southerly by said centerline of location to the point of beginning.



**RESIDENCE "A"****HAMPTON VILLAGE**

Beginning at a point distant 300 feet easterly from the easterly sideline of Lafayette Road and distant 200 feet northerly from the northerly sideline of Anns Lane; thence running easterly by a line parallel to and 200 feet northerly from the northerly sideline of Anns Lane; thence running southeasterly by a line parallel to and 200 feet northeasterly from the northeasterly sideline of Mace Road; thence running southwesterly by a line parallel to and 200 feet southeasterly from the southeasterly sideline of Locke Road; thence turning running in a general westerly direction by a line parallel to and 200 feet southerly from the southerly sidelines of Winnecummett Road and Park Avenue to a point distant 300 feet easterly from the easterly sideline of Lafayette Road; thence turning and running northerly by a line parallel to and 300 feet easterly from the easterly sideline of Lafayette Road to a point 300 feet southerly from the southerly sideline of High Street; thence turning and running easterly by a line parallel and 300 feet southerly from the southerly sideline of High Street to the westerly boundary of land of the Advent Church projected southerly across High Street; thence turning and running northerly by said westerly boundary projected to a point 300 feet northerly from High Street; thence turning and running westerly by a line parallel to and 300 feet northerly from High Street to a point 300 feet easterly from the easterly sideline of Lafayette Road; thence turning and running northerly by a line parallel to and 300 feet easterly from the easterly sideline of Lafayette Road to the point of beginning.

**RESIDENCE "A"****NORTH BEACH**

Beginning at a point in the centerline of Little River Road at the North Hampton town line; thence running easterly by said town line to the Atlantic Ocean; thence running southerly by the Atlantic Ocean to land of the United States occupied by the Coast Guard Station; thence running westerly by land of said United States to Ocean Boulevard; thence northerly by Ocean Boulevard to a point 571 feet southerly from the southerly sideline of North Shore Road; thence running westerly 750 feet by a line at right angles to Ocean Boulevard to a point distant 200 feet southerly from the southerly sideline of North Shore Road; thence running westerly by a line parallel to and 200 feet southerly from the southerly sidelines of North Shore Road and North Beach Road to a point in the centerline of Little River Road; thence turning and running northeasterly by the centerline of Little River Road to the point of beginning.

**RESIDENCE "A"****GREAT BOARS HEAD**

All of Great Boars Head lying easterly of a line which is parallel to and 100 feet easterly from the easterly sideline of Ocean Boulevard.

**RESIDENCE "B"****HAMPTON VILLAGE**

Beginning at a point in the easterly sideline of Lafayette Road distant 540 feet northerly from the northerly sideline of Anns Lane; thence running westerly by a line at right angles to Lafayette Road to the centerline of location of the Boston and Maine Railroad; thence running northerly by said centerline of location to the easterly sideline of Lafayette Road; thence running northerly by the easterly sideline of said road to the North Hampton town line; thence turning and running easterly by said town line to a point 300 feet easterly from the centerline of location of said railroad; thence turning and running southerly by a line parallel to and 300 feet easterly from said centerline of location and by a line parallel to and 300 feet easterly from the easterly sideline of Lafayette Road to a point in a line at right angles to Lafayette Road through the point of beginning; thence turning and running westerly to the point of beginning.

**RESIDENCE "B"****HAMPTON BEACH**

Beginning at the northeast corner of the lot fronting on Haverhill Street and Ocean Boulevard; thence running easterly by Haverhill Street to Atlantic Ocean; thence turning and running southerly by the Atlantic Ocean to the State Park; thence turning and running westerly by the State Park to the rear line of the lot fronting on Ocean Boulevard; thence turning and running in a general northeasterly direction following the rear lines of the lots fronting on said boulevard to the point of beginning.

**RESIDENCE "B"****NORTH BEACH**

Beginning at the intersection of First Street and the Ocean Boulevard; thence running westerly by the centerline of First Street and its extension westerly to Eel Ditch; thence running northerly by Eel Ditch and Meadow Pond to the northerly end of said pond; thence running northerly to a point 200 feet southerly from the intersection of North Shore Road and North Beach Road; thence running easterly by a line parallel to and 200 feet southerly from the southerly side line of North Shore Road to a point 750 feet westerly at right angles from Ocean Boulevard; thence running southerly by a straight line to a point distant 600 feet westerly from Kings Highway; thence turning and running easterly by a line at right angles to Kings Highway 600 feet to

a point in said highway 150 feet northerly from the northerly sideline of 19th Street; thence running northerly by Kings Highway to High Street; thence running easterly by High Street to Ocean Boulevard; thence running southerly by Ocean Boulevard to the centerline of First Street; and the point of beginning.

**BUSINESS DISTRICT**

**HAMPTON VILLAGE**

Beginning at a point in the easterly sideline of Lafayette Road, distant 540 feet northerly from the northerly sideline of Anns Lane; thence running easterly by a line at right angles to Lafayette Road 300 feet; thence running southerly by a line parallel to and 300 feet easterly from Lafayette Road to a point 300 feet northerly from the northerly sideline of High Street; thence turning and running easterly by a line parallel to and 300 feet northerly from High Street to the westerly boundary of land of the Advent Church; thence turning and running southerly by the westerly boundary of land of the Advent Church projected southerly across High Street to a point 300 feet southerly from the southerly sideline of High Street; thence turning and running westerly by a line parallel to and 300 feet southerly from the southerly sideline of High Street to a point distant 300 feet easterly from the easterly sideline of Lafayette Road; thence turning and running in a general southerly direction by a line parallel to and 300 feet easterly from the easterly sideline of Lafayette Road to the Hampton Falls town line; thence turning and running northwesterly by the Hampton Falls town line to a point 300 feet westerly from the westerly sideline of Lafayette Road; thence turning and running in a general northerly direction by a line parallel to and 300 feet westerly from the westerly sideline of Lafayette Road to the centerline of location of the Boston and Maine Railroad; thence running northerly by the centerline of location of said railroad to a point on a line at right angles to Lafayette Road through the point of beginning; thence running easterly to the point of beginning.

**BUSINESS DISTRICT**

**NORTH BEACH**

**HIGH STREET AND BOULEVARD**

### Report of Sewerage Committee

Town of Hampton, N. H.

The following is a brief report of the work we have done in preparing plans and specifications for the circulation of sewers and a sewerage treatment plant for the extension of the sewer system to the main part of the town. We engaged the engineering firm of Burns and Kenerson, Inc., on July 2, 1947 to make surveys, stud-

ies, and other investigations necessary to complete the plans and specifications for the construction of this sewer extension.

Application was made to Federal Works Agency of the Bureau of Community Facilities for \$8,250. to pay for this survey. The application was accepted and the money allotted to the town of Hampton.

The Sewerage System prepared for the Village section includes all sections of the village where sewers can be constructed and flow by gravity to the sewage treatment plant area through an intercepting sewer starting near Park avenue and Landing road.

The approximate cost for the above work is estimated as follows:

Construction of Sewers at Hampton Village	\$114,000
Construction of Treatment Plant	86,000

## REPORT OF SUPERINTENDENT OF SCHOOLS

---

To the School Board of Hampton:

I herewith submit to you my report as Superintendent of your schools. Included will be reports by the Headmaster of the High school, and the Principal of the Centre School. The various heads of departments have also been asked to summarize the work of their respective programs. Their reports will be of interest to the people of Hampton. The statistics presented are those of the last completed school year except that the September pupil enrollment is that of the current year.

The present year began Wednesday, September 8, 1948 with an initial enrollment of 539 as compared with that of 530 the previous year. Late registrations have increased this figure to 562. A comparison by grades will show Hampton following the nation-wide trend of larger entering classes each year. The kindergarten has increased from 24 to 39 in one year. The first grade increased by seven and the second grade by two pupils. As this trend continues and the larger grades move up the situation will become continually more urgent. It would seem that the only answer is an addition to the school buildings. Even if it were physically possible to seat such large numbers it is unfair to ask teachers to teach forty or more pupils, as we now have in four rooms. Likewise it is unfair to the pupils since necessary individual attention cannot be given so successfully under such circumstances.

Accepted standards recommend thirty square feet for each pupil station with a minimum of twenty-five square feet. The Centre School by the 30 foot standard should house 198 pupils. If the 25 square feet is used as

the measure the building should accommodate 242 pupils. These figures are broken up by the following table.

As the best temporary means of helping the overcrowded situation two additional teachers were employed. The kindergarten with its enrollment of 39 was far above the recommended number of 25. A helping teacher is also working in the Centre School with the major part of her work in grades one and four.

Last September a census was taken of all children in Hampton. This indicates that the prospective enrollment of each first grade, at least for the next four years will be above forty. This number will be increased as more families move into town. It would seem wise to make a complete survey of the district to determine present and prospective educational needs. A study should be made of population trends and of the type of service needed in Hampton. The rate of building, the earning power of new population and the business prospects in the town must be considered. To receive accurate data on these varying elements a group of people trained in such



work should be engaged. It would be the duty of this group to make recommendations as to actual needs of our pupils and to report those needs to the school board. As a result of the work of this group, the district would be enabled to construct a type of school built for Hampton and its pupils rather than a somewhat vague "good modern school." Such survey and consultant groups are continually at work where ever careful planning is the objective.

Hampton retained most of its teachers of the previous year. An experienced staff is an asset to any district since the teachers understand the school policies from previous years as well as the individual pupils themselves. The teachers new to Hampton High School are Mr. Emery Flavin, a graduate of Bates College and Miss Joanna Cass, a graduate of the Commerce Course of the Salem State Teachers College.

At the Centre School, Miss Mildred Allen, a graduate of Keene Teachers College was secured to replace Mr. Noel Salomon who resigned to go into business. The two assistant teachers, Mrs. Edna Berry and Mrs. Ruth Snider are well known in Hampton; Mrs. Berry as a former teacher of grade two and Mrs. Snider for her very successful kindergarten. The present staff is working as a unit toward ever greater service to our children.

To be certain that our schools are in line with the most successful systems the seven towns of Supervisory Union 21 have joined the New England School Development Council. This Council is composed of ninety of the leading schools of New England. Its purpose is to develop more efficient courses of instruction, more functional school plants and to bring the needs of Education nearer to the people. Studies are made of the entire school offerings and recommendations made. At the present time an Evaluation of the Secondary Schools is being

conducted by this group. Hampton is one of the participating schools. Headmaster Russell is a member of the steering committee for this evaluation. The resulting conclusions will be of real worth to our school.

The new handwriting system, mentioned by Principal Bowie in his report, has proven successful in bringing to our schools an expert teacher of the subject. Unity of style, method and objective are secured by placing one teacher in charge of all the work.

Since Reading is the basis of many school subjects, it is suggested that a remedial teacher in this work would be a wise investment for the district. This teacher would give special attention to those pupils having difficulty with the fundamentals of reading. There is the alternate possibility of securing a teacher qualified to do remedial work in other basic subjects as well as reading. Since there would be a close correlation with reading in all subjects the latter method would seem to be more economical. If such a teacher can be found, I am recommending her employment.

The schools of Union 21 united with those of the Exeter Union to hold a workshop for the teachers during the week of November 15 to November 19, 1948. These five days were spent for "in-service" training. The state supervisors were in charge and brought to us the latest and most approved methods of presenting subject matter. The first two days were under the direction of Dr. Gertrude Lewis, Director of Elementary School Services for the New Hampshire Board of Education. She discussed the social studies of the elementary school, outlining the entire program and helping to solve many of the problems found by teachers in their daily work. It was literally a workshop in which teacher committees worked on definite problems and arrived at their own conclusions based upon modern practices.

The last three days of the week were in charge of Dr. Lura Bruce, State Supervisor of Health and Miss Grace E. Felker, Director of Physical Education. A critical study of the health program was made. Ways of guarding the health of our children, both in school and out, and of preventing accidents were considered. The proper use of the playground as well as the school building for physical development was explained and illustrated. These workshops were held in a majority of the districts of the state. Those who did not receive these services will be offered them next year.

The small towns are constantly allowing some of the talent developed locally to move to the larger cities despite the fact that the small town offers many opportunities for young people. It would seem that the pupils in our schools should know what the local community has to offer them. The schools, even in the lower grades, should develop a greater interest by school children in their own town. To this end it is suggested that definite time be allotted in the school program for the study of local history, — the story of its founding, landmarks, folklore and special events of interest. Also included in the work should be the story of how our people now make a living together with the advantages of working in the town. The question, as to what the town now does to benefit its citizens would prove of value in stimulating future participation in government offices. The development of an interested and active citizenry will surely react to the benefit of any town or city.

To the local Parent Teacher Association the schools are indebted not only for financial contributions and special projects but, perhaps of more importance, its understanding and interest in the work of education. The schools need this help, especially during the next few years when problems will be more difficult from year

to year. The local PTA has been generous in its support of the school lunch program. The dancing classes, sponsored by this group, prove valuable allies to the school in developing normal social adjustment among pupils as well as a healthy group consciousness. Such a project must react to the good of the school as a whole.

The Trustees of Hampton Academy and High School have continued their generous policy of contributing funds for the purchase of equipment for the Academy. During the past summer, the Trustees approved the payment of costs for installing the oil burner in the school. This has made a noticeable improvement in heating the classrooms. They have also purchased two new typewriters and much equipment for the lunch program and Mechanic Arts department. Our High School moving picture projector was also a presentation of the trustees.

Three major improvements have been made in the school plants since the former report. Complete new installations have been made in the boys toilets at the Centre School, replacing the outdated equipment. Oil burners have been placed in both school buildings, the Academy burner being paid for by the Trustees and the Centre School by the school district. The installation of fluorescent lighting, begun the previous year, has been completed for all classrooms at the Centre School. All three of these add to the health and comfort of our pupils. A most interesting experiment has been tried in the first grade of the Centre School with the Red Cross contributing the cost of placing germicidal lamps in the room. Two lamps, as recommended by health authorities, were used on the room walls. While it is still an experiment, it is noticeable that the number of absences because of colds is materially less than in former years.

As a further step toward guarding the health of our pupils, the district now employs a full time nurse. Mrs.

Barbara Brown has her office in the Centre School and is in the building each school day. This plan guarantees a careful watch of our children in case of illness.

The lunch program continues as in the previous year. We have received help from the PTA and the Trustees of the Academy in the purchase of needed equipment which has allowed us to keep the price to the children at a low cost. The Red Cross has also continued its policy of previous years by contributing regularly the cost of meals for approximately ten pupils. While the number of children served varies, the average daily participation is 200. We received at intervals, various surplus commodities from the U. S. Department of Agriculture. These products are used to supplement our regular menu. Orange juice, grapefruit juice, potatoes, etc., are welcome additions to the program. In the near future a cafeteria should be installed in the High School building. We are serving lunches now by carrying the food from the Centre School. With a modern cafeteria the lunch program could be expanded and made more attractive for the pupils.

Hampton Supervisory Union is now working with the leading schools of New England to improve its service to the pupils and the community. For help from the various organizations in town and for suggestions from its citizens we are grateful. It is our purpose to continually improve the work of the schools. We shall need the cooperation of all. For your help and cooperation as a board, I wish to express my appreciation. Much has been done during the past year. With your continued insistence of the best for Hampton, we shall keep in the forefront among the schools of the state.

REPORT OF HEADMASTER  
HAMPTON ACADEMY AND HIGH SCHOOL

Dear Mr. Gillmore:

I herewith submit to you my annual report as Headmaster of Hampton Academy and High School.

Each year for the past several years there has been a small increase in the size of the school until now we have 212 pupils. We expect to graduate a class of about forty. The entering class was sixty-four. I anticipate that this growth will continue. Our classes have gradually increased until it is desirable to section some of them. We are getting close to the point where it would be wise to add another teacher and operate another home room. This would mean using either the science room or the music room for that purpose. We would need home room desks if we decide that is best. We can tell more accurately in the spring when we are working on next year's schedule.

We are having difficulty in scheduling all our activities. The physical education department wants longer periods. The music department would like to have rehearsals during school hours. We would like to section our largest classes but cannot because the teacher must be used for a study hall. We were unable to add a course in driver education because we could not free a teacher and enough pupils at the same time. Nobody wants the school day to be lengthened enough to allow for eight periods instead of our present seven. In order that more people may understand the problem we are having a committee of teachers work on the problem during the spring. We would welcome any help or suggestions for we realize that the efficient operation of the school depends on the best possible schedule.



I want to say a word in commendation of the workshop which was held in November. It was the first time in my experience that teachers were permitted time to sit down and discuss their common problems. We are usually so busy with the operation of the school that we never get to the formation of a basic philosophy. The opportunity to pool our ideas with others in a similar situation and plan a course of action was a unique experience.

Our program in visual education in charge of Mr. Smith, has been very effective. Our new projector has been very satisfactory. Mr. Smith has trained a group of students to do the projecting which frees the teachers and gives the students valuable experience. We have recently acquired a tape recorder for use in our classes. We have used it in English, music and commercial classes and found it a valuable addition to our equipment.

We are in our first year of control of athletics by a council. A constitution has been formed which provides for the control of athletics by a council consisting of a school board member, the superintendent, headmaster, principal, coaches, president of the Student Council, a boy elected by the letter men and a girl elected by the girls who have won their letters. They meet on the first Wednesday of each month. It has transferred a great deal of work formerly done by the headmaster, to the new treasurer, Mr. Brown, and has provided a more democratic method of reaching decisions. The additional funds provided, have equipped our teams better than ever before and have made it possible for us to use a bus to transport our teams.

Our music department still finds itself in competition with other activities for the time and interest of our pupils. Since most of our other activities are on a full time basis by one or more people, they are at a disad-

vantage. If we want them to make a good showing, they should have equal support. We have been permitting the use of the building for private lessons during study periods. I believe this is a forward step and should be encouraged.

Our vocational department is doing some excellent work under the able direction of Mr. Parker. We would like to have him full time whenever you feel it is possible.

Our building and equipment is in excellent condition. I would like to have the desks resurfaced next summer. A wind deflector on the most-used window in each room would be helpful. There is need for more filing space in the office.

I want to commend our teachers. They have given their wholehearted co-operation. They are earnest and sincere in their work. I hope it will be possible to maintain them in their present positions.

Last year we graduated a class of forty-nine, the largest in the history of the school. Fifteen entered colleges, six go to Business Schools, two to Nursing Schools, and two entered the armed services. Twenty are employed in our local businesses as clerks, waitresses or general work. Two are married.

I have not tried to give a complete report for it would be too long for this purpose. I have tried to call your attention to matters which need co-operative effort. Alone we cannot accomplish much, but all together we can. I thank you for your past assistance and earnestly ask your continued help.

## ANNUAL REPORT OF CENTRE SCHOOL

Superintendent of Schools:

Herewith submitted is the annual report of the Centre School for 1948-1949.

We have made very satisfactory progress at the Centre School during the past year. Our enrollment has increased about 5% from 295 children last year to 311 at this writing and we, like many others, are beginning to feel the need for expansion. Present indications are that the first grade next year will be even larger than the record grade of 47 we now have.

There have been several changes in the staff, which brought Mrs. Berry to assist us in the first and fourth grades, while Miss Allen came to us replacing Mr. Salomon who decided to go into business for himself. She is teaching all of the Junior High School social studies. Both changes have been valuable additions to our school staff, which otherwise remains unchanged.

The Rinehart Functional Handwriting System has been installed in our school this year with gratifying results. Under this system children do weekly lessons and are supervised by the teacher on all written work. Each month a representative of the system visits and personally supervises one lesson in each room. While at the school she corrects existing faults in position and form, then grades the preceding months' papers. Each grade in School is now working hard to attain the gold star standard which indicates excellence in writing.

Teachers have been enthusiastic over this new course and improvement in handwriting is practically universal throughout the school.

The Junior High School has been very active in various

co-curricular activities during the past year. Besides boasting better than average basketball and baseball teams under the capable leadership of Mr. Eastman they have found time to present a three-act play and an operetta. Participation in sports and public appearances is an integral part of the process of education and should be a part of each child's educative experience.

Plans are now being formulated for some sort of an outdoor Pageant in the spring which will embrace practically the entire school.

Our Guidance Program has taken final shape and seems to be working out well. Last year a Cumulative Record for each pupil was started and is now being more completely utilized. The eighth grade last year was given individual counsel on the basis of various measuring devices and personal observations by teachers. Each child was guided into what was considered the best high school course for him.

This year on the basis of records, measuring instruments and pupil observation we shall try to guide and counsel all in school who are in need of advice. The value of guidance can be more clearly seen in a long term affair that progresses in school using this information to see that each individual child gets the most out of school for what he has put into it.

The superintendent, school board and townspeople deserve a commendation for their efforts in getting the new lighting system into the school, as well as the new oil heat to replace the worn out coal furnace. These changes are welcome and valuable. Also the new color scheme that was done in the first and fifth grades has received most favorable comments from faculty and pupils. We all hope that other rooms may be completed along a similar plan next year.

It is deemed advisable for someone to investigate the condition of the school roof with the possibility that repairs may be needed this year.

I wish to take this opportunity to thank those who helped make the past year a happy and profitable one for the Centre School.

## MUSIC DEPARTMENT

Dear Mr. Gillmore:

I submit the following report of Music in the Hampton schools during 1948.

At the Centre School, we are trying to more nearly approach the ideal of the five point music program: singing, playing, dancing, creating, listening. The purchase of some new records in the fall has given pupils of Junior High age, as well as elementary pupils, the chance to do some intelligent listening. More physical response to music is also encouraged.

The members of the Junior High School and members of its faculty worked together this last fall to produce an operetta, "The Forest Prince." It was a great success as a school activity.

Two movies on musical subjects have been used at both the Centre and High Schools.

During the last year our high school pupils took part in three music festivals, two New England and one State Festival. Your supervisor helped Mr. James Tucker and the Hampton Beach Chamber of Commerce to put on the New England Auditions Festival in May when over 6,000 boys and girls came into the town to participate in the Festival. Our school faculty, the people of our Town of Hampton and Hampton Beach gave of their time and strength to help make this Festival a success. For this, I sincerely thank them.

In addition to the customary musical activities of the year, the High School Glee Clubs presented a concert and an operetta, thus earning a substantial sum toward band uniforms. The operetta was a school activity and all members of the faculty assisted in its production.

I wish to express my sincere thanks and appreciation to our townspeople for their kindness and loyalty, expressed in the many gifts of money toward the purchase of beautiful new uniforms for the School Band. Our activities of last year certainly stimulated interest in the band. It has increased from a membership last year of 25 players to a membership this year of 40 players, not counting majorettes and drum major.

I appreciate very much the support, and understanding given me by the Board of Education and you, Mr. Gillmore, thru' all the many problems of this last year.

## PHYSICAL EDUCATION

Dear Mr. Gillmore:

Following is my annual report of the programs in Physical Education and Athletics.

Physical Education activities at the Centre School have been carried on twice a week in grades one through six, and once a week in grades seven and eight.

The ability to handle one's own body with greater ease and efficiency may increase the capacity to enjoy life since it helps the individual to overcome self-consciousness. To achieve this in the primary grades, the content has been largely simple group games and mimetics. In the upper grades, the games are more highly organized and lead to modified team games, relays, self-testing activities where the emphasis is on cooperativeness with in the group.

In the Junior High School, the program has consisted of teaching game skills in Touch Football, Softball, Soccer, Basketball and Track. Certain elements of the Athletic Badge Tests have been used. Other activities have been combatives, stunts, and teaching skills in balance, tumbling and pyramids.

At the High School, all pupils participate in team program twice a week, unless one is a member of a varsity team or is excused by a doctor. The activities include self-testing stunts, team sports, skill tests, badminton, combatives, tumbling and pyramid building.

The conclusion of the winter sports season again brought intramurals in basketball and volleyball. This was carried on in the form of a consolation-elimination tournament. The intramural program in basketball has



now been greatly extended as Mr. Brown has over forty boys competing in a Round Robin Tournament.

## ATHLETICS

Through the interest of our community, more money was made available so that the varsity teams enjoy new and better equipment, particularly in the rugged game of football. Another advance in the safety and well-being of the players has been the arrangement whereby all teams travel by bus.

In the seven varsity sports in our athletic program, approximately 150 boys and girls competed with other schools in 77 games and meets.

Highlights of the year were the successful season in girls' basketball, and the undefeated season in Football. Track, in its second year, doubled in the number of participants, and at the interscholastic meet in Durham, secured eight places. Three boys were invited to the New England Track Meet where a place was secured in the High Jump.

I wish to take this opportunity to thank the citizens of Hampton, the school board, the superintendent of schools, headmaster, principal and teachers for their interest and cooperativeness to these programs.

## GIRLS' PHYSICAL EDUCATION

The Physical Education program for girls starts with the seventh grade. In the Junior High the girls have one period a week and these classes are held out of doors when the weather permits. The ability to play together is the main objective of this group and the low organized games are used whereby the children may enjoy themselves and not be constantly interrupted for corrections. Junior High is also the ideal age to start the fundamentals and skills of the competitive games. Field Hockey proved to be quite popular this fall. Volleyball, basketball, and softball will be offered during the course of the school year.

In the High School, Physical Education classes are scheduled twice a week for each student and it is a required subject unless a student has been excused by a doctor from physical activity. In the program at the High School there is a wider variety of activities due to the greater number of students and the better facilities for gymnasium work. We also hold classes out of doors when it is possible. Field Hockey and Archery are the sports of the fall along with gym work such as drill, posture exercises and stunts. In the winter basketball is the major activity and some volley ball is played. When spring arrives softball starts outdoors and during the bad weather stunts, tumbling, badminton, volleyball, and group games are played indoors.

This regular Physical Education program is supplemented with three interscholastic team sports. Field Hockey starts in September and the team plays four games. Basketball runs from December through February and the schedule consists of from ten to fourteen games. Due to the long season and the required practices of the basketball season, the girls who are on the varsity

squad are excused from the regular Physical Education during the three months of the season. Softball begins as soon as the weather permits in April and the girls usually play four to six games.

The development of recreational interests, the learning of skills to be used in leisure time, the creating of sportsmanship and good citizenship, and the ability to play together as a group are some of the objectives of the Physical Education Program.
